Cobb County Superior Court Clerk's Office will begin eFiling

Electronic filing for civil court cases to be available in April 2016

Cobb Superior Court Clerk will be accepting civil pleadings and other documents via E-filing. **PeachCourt** has been selected as the E-filing solution platform, giving lawyers the ability to initiate a new civil case or file documents into an existing civil case in Cobb County Superior Court remotely and securely 24 hours a day, 7 days a week. Furthermore, all case information and case documents can be viewed on the Clerk's website at www.cobbsuperiorcourtclerk.org at any time.

"We chose **PeachCourt** for three reasons. First, the platform connects more of Georgia's courts than any other and we understand how valuable it is to reach as many courts as possible within a single system. About GreenCourt

In 2014, the **Council of Superior Court Clerks of Georgia** chose GreenCourt as a partner to establish an eFiling platform that serves the entirety of the state's justice system – any filing by any filer in any court. The product of the partnership, **PeachCourt**, opened in December 2014 with its first filing in Fayette Superior Court. Since then, PeachCourt has grown to include more than 110 courts available for eFiling and more than 30 courts available for case document access. In 2014, Georgia Lieutenant Governor Casey Cagle presented GreenCourt with his "Excellence in Innovation" award.
