### COUNT 1

The Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, charge and accuse **JASON VINCENT KRISANTZ** with the offense of **AGGRAVATED ASSAULT, O.C.G.A. 16-5-21**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did make an assault upon the person of Jennifer Meryl Edwards, with intent to murder her, by placing his hands around her neck and applying pressure, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 2

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **AGGRAVATED ASSAULT, O.C.G.A. 16-5-21**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did make an assault upon the person of Jennifer Meryl Edwards, with a full glass bottle of alcohol, an object which when used offensively against a person did result in serious bodily injury, by striking her with it, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 3

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **KIDNAPPING, O.C.G.A. 16-5-40**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did unlawfully abduct Jennifer Meryl Edwards, without lawful authority or warrant and held such person against her will, said act resulting in bodily injury to Jennifer Meryl Edwards, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 4

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **FALSE IMPRISONMENT, O.C.G.A. 16-5-41**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, in violation of the personal liberty of Jennifer Meryl Edwards, did unlawfully confine and detain, Jennifer Meryl Edwards, without legal authority, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 5

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **TERRORISTIC THREATS, O.C.G.A. 16-11-37(b)**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did while suggesting the death of Jennifer Meryl Edwards, with the purpose of terrorizing her, threaten to commit any crime of violence, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 6

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **THEFT BY TAKING, O.C.G.A. 16-8-2**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did unlawfully take a 2016 Kia Soul, the property of Douglas Edwards, with a value of five thousand dollars (\$5,000.00) or more, the exact value being unknown to the Grand Jurors, with the intent to deprive said owner of said property, , contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 7

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **BATTERY, FAMILY VIOLENCE, O.C.G.A. 16-5-23.1(f)**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did intentionally cause visible bodily harm, to wit: red marks, to the person of Jennifer Meryl Edwards, said person and the accused were formerly living in the same household, by striking her, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 8

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **JASON VINCENT KRISANTZ** with the offense of **BATTERY, O.C.G.A. 16-5-23.1**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 24th day of March, 2023**, did intentionally cause substantial physical harm, to wit: marks, to Jennifer Meryl Edwards, by striking her, contrary to the laws of said State, the good order, peace and dignity thereof.
